FINAL PLAT APPLICATION

The purpose of a Final Plat Application (FP) is to allow for the subdivision of land into 10 or more lots, tracts, parcels, or divisions for the purposes of sale, lease, transfer, or building development. The Final Plat is the final drawings of the subdivision and dedication prepared for filing for record with the King County Department of Records and Elections and containing all elements and requirements set forth in [Chapter 58.17 RCW](#) and in the Snoqualmie Land Use Code.

FINAL PLAT APPLICATION SUBMITTAL REQUIREMENTS:

1. Completed Application Form (see Page 3)
2. Updated Plat Certificate
3. Computer-generated calculations showing closure of all created lots and tracts
4. Evidence that all required sureties have been approved and are in effect
5. Evidence that any required covenants, conditions and restrictions applicable to the subdivision have been duly executed and recorded
6. Confirmation that the final plat application complies with all the requirements of [SMC 16.08.070](#)(B) through (E)

- 1. Completed Application Form.** (See Page 3).
- 2. Updated Plat Certificate.** A Plat Certificate from a title insurance company documenting the ownership and title of all interested parties in the plat and listing all encumbrances. The Plat Certificate must be dated within 30 days from the date of the application.
- 3. Computer-generated calculations showing closure of all created lots and plans.** Provide complete field calculations and computations noted for the plat and details (if any) of all distances, angles, and calculations together with information on the error of closure.
- 4. Evidence that all required sureties have been approved and are in effect**
- 5. Evidence that any required covenants, conditions and restrictions applicable to the subdivision have been duly executed and recorded.** Provide documents containing all applicable restrictions and conditions, if any, required by the Hearing Examiner or at the discretion of the property owner, to be imposed on lots and tracts within the subdivision. Also, provide accurate outlines/purposes of use for any areas reserved by deed covenant for common use of owners of property within subdivision.
