## A New Year's Message from Mayor Matt Larson

While 2020 was a difficult year, 2021 is opening with a glimmer of hope with COVID-19 vaccines available and more on the way. I am thankful that Snoqualmie has had very few positive cases – one of those being me last March – and the community continues to be vigilant in safety measures. Despite challenges to our city budget, I was grateful that the City Council supported the continuation of our holiday lights downtown and on Center Blvd. We all need to seek ways to keep spirits bright during this difficult time.

Here are a few other bright spots that happened last year.

- Six thousand pounds of food was donated by residents during the Santa Parade for the Snoqualmie Valley Food Bank.
- Relief funding totally \$645,000 was provided to Snoqualmie businesses and non-profits serving Snoqualmie residents.
- The City Council approved \$464,574 to be allocated to local human services organizations over the next two years.
- Three blood drives at City Hall resulted in 515 units of blood donated to support Bloodworks Northwest programs. The blood is used at 80 hospitals including the Snoqualmie Valley Hospital.
- The Wastewater Treatment Plant received an Outstanding Performance Award from the Department of Ecology for the second year in a row.
- Snoqualmie was again recognized as the Safest City in Washington, making that five times Snoqualmie has received a safety award.
- Snoqualmie Police Officer Rick Cary received an award for Washington Air National Guard Outstanding Security Forces Airman of the Year.
- Snoqualmie Police Officer Jayce Gutzler was voted by readers of 425 Magazine as Police Officer of the Year.
- Mount Si High School had its first ever Graduation Parade!

## Skookumchuck Wind Facility Provides Energy for City Facilities

Puget Sound Energy's new Skookumchuck Wind Facility is now providing renewable energy to its Green Direct customers, including the City of Snoqualmie. All facilities owned by the city, such as buildings, parks, and lift stations, are now powered by clean, renewable energy not derived from fossil fuels. The Skookumchuck Wind Facility is in Lewis and Thurston counties, and is the largest wind project in western Washington. ## Reduced Rates on Utilities Available for Lower Income Households

Households with lower incomes prior to or resulting from the COVID-19 crisis can apply to a variety of programs for assistance including reduced rates on water utility bills. ## Comprehensive Plan Docketing Process

The Comprehensive Plan docketing process provides an opportunity to propose changes to the city's Comprehensive Plan, zoning code, or development regulations per Snoqualmie Municipal Code Title 21. Proposals typically address new conditions or emerging issues and may propose changes to city policies or allowed land uses. Any individual, business, organization, or group may submit recommendations through October 31 of each year.
