2. 1.08 BID EVALUATION AND CONTRACT AWARD

CURRENTLY READS:

In accordance with the provisions of these Contract Documents, bids will be evaluated to determine the lowest Total Bid Price and a contract will be awarded, if at all, to the responsive and responsible Bidder with the lowest Total Bid Price. The Bidder must meet the requirements of a responsible Bidder as established under RCW 39.04.350 and 39.06.020, and the supplemental bidder responsibility criteria in Section 00-04-00.~~

REVISED TO READ:

- A. The Bidder must provide bid prices for all the Base Bid Items and the Additive Bid Items. A proposal that does not include prices for all items will be considered non-responsive and will be rejected. Bids will be evaluated to determine the lowest Base Bid Price as well as the lowest Base Bid Price plus any or all additive bid items. The City will decide to award the contract based on either the lowest Base Bid Price or the lowest Base Bid Price plus any or all Additive Bid Items. None of the additive items will be awarded as a separate project under this contract. In accordance with the provisions of these Contract Documents, bids will be evaluated to determine the lowest Total Bid Price and a contract will be awarded, if at all, to the responsive and responsible Bidder with the lowest Total Bid Price. The Bidder must meet the requirements of a responsible Bidder as established under RCW 39.04.350 and 39.06.020, and the supplemental bidder responsibility criteria in Section 00 04 00.**
